<b>Districtwide A&amp;R All Staff Training Retreat</b>	<p>On Friday, February 23rd, Los Rios held its first ever districtwide training retreat for all Admissions and Records staff held at CRC. President Bush and VPSS Emiru provided welcoming remarks to kick-start the day. Dean Andre Coleman presented a training on the Caring Campus Approach and Handling Difficult Situations. The A&amp;R team participated in introspective activities across the District in the afternoon, collaborated on values integral to Admissions &amp; Records and brainstormed objectives on our pathway to continuous improvement. <b>Payment Due Date &amp; Autodrop for Summer 2024</b>	<p>The payment deadline for students enrolling on or before June 10th for Summer 2024 is Monday, May 27th. <b>Course Applicability Major Change Requests</b>	<p>The Automated Change of Major process launched last month on 2/11 and yesterday, March 3rd, was the major change deadline for Spring 2024. Beginning today through June 30th, major changes submitted through the automated process will be effective for Summer 2024. With Spring enrollment underway through the end of the term and with Fall enrollment beginning on April 15th, an exception process has been established for students impacted by course applicability outside the Automated Major Change deadlines. Financial Aid will contact students impacted via email and provide a link to the form for each campus. Admissions &amp; Records will manually backdate or future date the exception request to mitigate course applicability impacts.</p>
