Change to Summer/Fall 2025 CCCApply Timeline

The summer and fall 2025 CCCApply applications will open on February 1st, 2025. For many years, the summer/fall application process opened on February 1st of each year. In 2018, the opening date of the application changed to October 1st of each year. While the goal was to align with the UC/CSU application timeline (October 1-November 30), this change has resulted in greater complexity and challenges in A&R and confusion for students (who inadvertently apply for the wrong term when intending to enroll in spring classes because both applications for current year and new year are open at the same time). At the recommendation of the A&R Supervisors, and with the support of college VPSS's, Outreach Deans, and the DESSC, the recommendation was approved to restore the February 1st release date for the summer/fall application..

Dual Enrollment Updates

A new special admit form will be available for dual enrollment students to use online beginning October 28th to support student self-registration beginning December 5th.

The new special admit form is designed to be completed one time in the dual enrollment student lifecycle so long as the student maintains continuous enrollment. The new form simplifies the process for incoming students and adapts to the information the student provides to ensure any supplemental information the student would need to provide as part of the admissions process is collected. The form also will be completely electronic and eliminate the need to email PDF documents back and forth further streamlining the dual enrollment process.

AB1232 Non-Resident Tuition Exemption Implementation Update

Beginning October 15th, students may apply for the AB1232 nonresident tuition exemption for students who are taking ESL courses in their first year in California and who are considered a recent immigrant, refugee, or asylees. When approved, this exemption will apply for the duration of the student's first year in CA and will waive the non-resident fees of all ESL courses in which the student is enrolled.

AB1540 Implementation Update

Beginning with the 2024-2025 aid year, students completing the California Dream Act Application may now submit an AB540 via the Dream Act Application. Recently, the California Student Aid Commission made these AB540 submissions available to the colleges and we have been working with Financial Aid to obtain access for Admissions staff. We have also been working to establish a streamlined business process to incorporate these submissions that must be retrieved manually from CSAC. We anticipate full implementation to occur in the month of October.

Priority Registration for Spring 2025

Priority Registration for Spring begins November 25, 2024, for Priority 0; student parents may complete the dependent verification form in eServices through Tuesday, November 5th to be eligible for Priority 0.

Priority registration windows will open as follows for Spring 2025; note that when two priority windows share an open date, the lower priority window will receive the earlier registration times on that shared date.

Priority .75: 11/27

Priority 1.0: 12/2

Priority 1.1: 12/2

Priority 1.2: 12/5

Priority 1.3: 12/7
