1. CALL TO ORDER

Chancellor King called the Zoom Conference meeting to order at 3:00 p.m. New members of Chancellor's Cabinet introduced themselves.

2. FINALIZE AGENDA & MINUTES OF MEETINGS

The July 12, 2021 meeting agenda, as well as the May 10, 2021 minutes were approved.

UPDATE ON SOCIAL DISTANCING AND MASK REQUIREMENTS FOR FALL SEMESTER

Chancellor King shared that a communication will be sent tomorrow to all managers, faculty and staff regarding the District's policies on social distancing and masks for the Fall 2021 semester. Based on the current CDC and Cal/OSHA guidance, masks are no longer required for any fully vaccinated person, indoors or outdoors, at any of our facilities. All unvaccinated employees must still wear masks at all times indoors, and when riding in a vehicle with others. N95 masks will be available for employees upon request. This only applies to employees right now as we're still awaiting specific guidance from CDPH regarding a student requirement. Employees will be asked to self-attest on Employee Self-Service on their vaccination status. This is in-line with how the State of CA, UC and CSU are all managing the process. Social distancing is not anticipated to be a requirement for the Fall semester for in-person activities.

Members of Cabinet asked questions and provided feedback to help alleviate potential confusion in the communication. Academic Senate President Julie Oliver clarified that this is not a 10+1 issue that Senate can weigh-in on but expressed her appreciation for the opportunity for Cabinet to provide feedback.

3. COLLABORATIVE EFFORTS TO ENCOURAGE VACCINATIONS

Chancellor King led a discussion about efforts to encourage our students, faculty and staff to get vaccinated to prioritize the health and safety of our students, employees, and educational community on our campuses. Various ways to encourage vaccinations were discussed, noting that many who have chosen not to may have valid personal reasons for that decision.

4. FUTURE AGENDA ITEMS AND MEETING SCHEDULE

There will not be another Chancellor's Cabinet meeting until the Fall semester unless a need for a mid-summer update is needed.
