1. CALL TO ORDER

Consensus Task Force Report December 16, 2024

On September 23, a task force was formed to explore possible definitions of consensus in the context of this participatory governance group, which reaches recommendations by consensus. The task force consists of four members of the Chancellor's Cabinet (Paula Cardwell, Liz Geisser, Jason Newman, and Jacob Velasquez). After productive discussion of the matter, the task force recognized quorum as an important element of consensus and decided to address quorum in its deliberations. The task force presents the following for consideration by the Chancellor's Cabinet.

Consensus is, *roughly speaking*, widespread agreement. To make this more precise, we can specify an amount of agreement required, which can be done in various ways. It can be specified by reference to full membership or by reference to the members in attendance at a given meeting (e.g., "agreement among members *in attendance*" vs. "agreement among members"). Additionally, the amount of agreement can be specified by reference to a specific number of dissenters allowed (e.g., "agreement among members in attendance, *with no more than five members in dissent*") or by reference to a fraction of members in agreement (e.g., "agreement among *at least two-thirds* of the members in attendance"). Taking all this into account, the task force presents the following possible definition of consensus for consideration:

Consensus

A consensus within the Chancellor's Cabinet shall be defined as: agreement among at least three-fourths of the Chancellor's Cabinet members in attendance—under the condition that quorum has been reached. (If all 26 members are in attendance, consensus allows for no more than six members in dissent. If only 20 members are in attendance, consensus allows for up to 5 dissenters.)

Quorum

A quorum shall be defined as: two-thirds of the total membership of the Chancellor's Cabinet, with at least one member from each constituency group (faculty, classified staff, students, administrators).
