CALL TO ORDER

Chancellor King called the meeting to order at 3:00pm.

FINALIZE AGENDA & MINUTES OF MEETING

The agenda was finalized, and the minutes of the previous meeting were reviewed and approved. An update on Guided Pathways was requested for a future agenda item.

CHANCELLOR SEARCH UPDATE

Deputy Chancellor Nye provided an update on the Chancellor Search timeline. First-level interviews are scheduled for November 10 and 12, 2025. Second-level activities, including a candidate forum, will take place in early December.

ACADEMIC SENATE AI SUMMIT UPDATE

District Academic Senate President Paula Cardwell provided an overview of the upcoming AI Summit. The goal of the summit is to ensure the district remains a leader in the effective use of AI. The event will feature several high-profile speakers. Registration reached 200 participants within 24 hours.

OTHER UPDATES

- *Woodland Community College / Yuba CCD (SB 226 – Cabaldon)*
Executive Vice Chancellor Rodriguez reported that the related legislation has become a two-year bill to allow time for a FCMAT review. He provided updates on the district's monitoring of SB 226 and potential impacts.
- *State Budget & Enrollment*
Executive Vice Chancellor Rodriguez also provided an update on the current state budget outlook, noting that enrollment has been restored to above pre-pandemic levels. He discussed the legislative process, ongoing advocacy, and district strategies to secure funding for enrollment growth and ensure continued access for students. Planning is underway to address unfunded growth in next year's budget.
- *Dual Enrollment*
There was discussion regarding increasing dual enrollment and the resulting impact on high-demand classes across the district.

*During all terms, classes are offered in additional formats to enhance student opportunity: 1st and 2nd eight week sessions; 1st, 2nd and 3rd five week sessions; as well as weekend only classes. Examples might include four, five, six and eight week sessions and weekend courses, as well as other session lengths.

NOTE: Classes may be scheduled on all days during the Summer term including Friday through Sunday; the count of days, though, is Monday-Thursday only as those are the primary days when instruction is offered. Both the Fall and Spring terms have scheduled instructional days, such as Saturdays, that are not included in the number of days shown above. Those additional days ensure the district is in compliance with the requirements of Title 5 of the California Code of Regulations, sections 58120 and 58142.
