**Approval of agenda**

The agenda was reviewed and approved.

**ACC JC third-party comment**

It was noted that CRC has a link to a page that allows for third-party comments regarding accreditation. SCC asked whether that link should be available now or when the visiting team arrives. It was noted that the PIOs have been working on this with the AVC of Communication at district office. It was noted that on our timeline documents, August was set as the date to get the link available for public comment because that would be six months before the first visit. CRC shared the marketing plan they are using so that the rest of the group could duplicate it and/or check with their PIO.

**College check-in's**

ARC noted they are still working on their QFE. They are getting close to a final report and are linking evidence. It will go through the governance process next month and to executive leadership the first week of October.

CRC noted their participatory governance committee will review the document at the end of September 28 and then it will go to academic and classified senate.

FLC noted they completed their draft at the end of June and now they are focusing on content and the evidence links which should be done in the first next week or so. It includes a QFE.

SCC noted their ISER is complete and evidence is 99% done as well as the QFE. They hope to have all the readings/reviews finalized in October.

A question regarding formatting of the document was asked. It was noted the board meeting in November is on the 10th and generally items are due the Tuesday prior to that meeting (November 2). It was noted we need to begin thinking about the presentation we will make to the board as well. Each campus could present their QFE and a couple of highlights.

**Timeline updates**

The timeline for fall 2021 and spring 2022 was reviewed. It was noted the ACCJC college teams will meet February 22-25. The ACC JC district team will meet February 21. Both of these are handled exclusively by ACCJC and do not involve our personnel. Following these meetings, we may receive a list of concerns which we can address before the site visit in October.
