#### **Discussion** Items

6. Draft Communication to Board of Trustees Regarding Their Request for an AB 705 Update *Discussion on a draft communication to the Board of Trustees requesting waiting until two full semesters of data can be gathered before providing an update on the implementation of AB705.* 

Shubb shared a draft of a communication for the Board and DAS comments were included on the Google Doc. This is seen as an opportunity for informing and educating the Board on the role of faculty and academic senates in college and district curricular issues. The finalized document will also be shared with the four math department chairs to see if it addresses the concerns that they brought forward at the November 5 DAS meeting.

Aguilar reported that Deputy Chancellor Nye will work with a proposal to have an update report to the Board for the March Board retreat and a presentation at the August or September Board meeting, which would allow for the collection and review of relevant data from two semesters (Fall 2019 and Spring 2020).

7. Creation of an Accessibility Plan Implementation Senate Committee Discussion on the proposed charge, membership, and timing of a Senate Committee that will identify and examine the different resources required to implement the District Accessibility Plan (see Attachment A)

- Involves both professional development (training) and workload issues
- Need for each college to have representation
- Need for making third-party content accessible
- Academic freedom issues---will some materials not be allowed if they are not deemed accessible?
- Where will the recommendations of this group be sent?
- Use of Blackboard Ally only identifies 30-40% of accessibility issues (with partial remediation)
- Sean Keegan (SCC IT specialist) is working on a document noting accessibility roles and what would be most appropriate for both faculty and classified staff to perform.

#### Reports

8. Meeting with Deputy Chancellor Nye

The first fully-online degree (Business) to be developed for the District will be using mostly ARC courses. It was noted that there need for coordination across the colleges and also for the use of the college guided pathways mapping groups for this online pathway

The Academic Calendar Committee will be meeting in February to discuss the calendar for the 2022-23 academic year. The 2021-22 will go to the Board soon for adoption.

9. College Academic Senate Presidents

SCC---still working on faculty prioritization; looking at program review process

FLC---President Yamamura met with the senate to explain his re-ranking of faculty proposals (wish to expand departments with only one full-time faculty member); continued accessibility discussion.

CRC---AB 705 implementation discussions---possible resolution; presentation for potential of GE-themed GP patterns.

ARC---faculty hiring prioritization; upcoming agenda item will be on the content of Convocation.

11. District Matriculation & Student Success Committee---As reported in earlier meetings, Tercho noted that she and Mellonie Dixon have been examining the matriculation processes from all colleges. Title: District Accessibility Plan Implementation Committee Duration: Spring 2020 (1 semester)

# BACKGROUND AND NEED (Why is the committee necessary?)

In March of 2019, the LRCCD Technology Accessibility Task Force released a series of recommendations guiding the colleges towards meeting the following standards and guidelines related to accessibility of Information and Communication Technology (ICT):

- Sections 504 and 508 of the Rehabilitation Act of 1973;
- Title II of the Americans with Disabilities Act;
- Accessibility standards described in the Web Content Accessibility Guidelines (WCAG), version 2.0, levels A and AA (or the most current approved version);
- Title 5 § for distance education courses offered by the colleges.

LRCCD offers almost 10,000 course sections containing over 760,000 ICT content items, the majority of which require remediation in order to be compliant with Section 508 of the Rehabilitation Act of 1973. Remediating existing course materials has been documented to be extremely time-intensive and presents faculty workload issues not addressed in the LRCFT contract. Remediating existing course materials to ensure accessibility also requires expertise in fields such as Assistive Technology, Information Technology, and Instructional Design.

# PURPOSE AND SCOPE (What is the project expected to encompass? What are the boundaries?)

This committee will work to better understand the scope of the work required to create and remediate ICT, with a specific focus on instruction materials. The committee will also identify the types of resources needed.

The committee will:

- Inventory the scope of work required to meet accessibility standards and guidelines.
- Identify areas that faculty should be responsible to meet accessibility standards.
- Identify needed training resources for faculty to meet accessibility standards and guidelines.
- Identify areas of higher-level ICT accessibility issues that should not be completed by faculty.
- Identify the of workload impacts required to meet accessibility standards and guidelines.
