Chancellor's Cabinet Mon April 27th

Fall 2020 Schedule—will be live on May 22nd, and registration begins June 1st

Budget—district is planning for 10% reduction for all employee groups and for fall schedule; LRCCD Board of Trustees (BOT) advised to go to 15% and to be thoughtful about student portion of CARES funding, which is more restricted than initially hoped; BOT wants to be a fiscally sound

 National context to budget—throughout the national educational spectrum cutting and furloughing is happening; education funding in CA is very dependent upon taxes, but unemployment, sales, and corporate taxes will be significantly lower, so there is potential for 15-20% cuts long term

CARES money for operational use, how will the allocation of that money be determined? And how will constituencies be involved?

BOT wants to hear about operational CARES funding; fill holes of expenses already incurred; next tier will want to
make investments to approach the downturn to increase efficiencies; US Dept of Edu most recent guidance, FAQs get
more granular and still getting more information

Funding Formula-will there be any 'hold harmless' time frame given the COVID-19 crisis and not being able to always meet the needs of program completion in a timely manner

- Possible extension of two years has been mentioned, but not consensus among community colleges across the state
- Possible overall push to undo the entire funding formula
- Legislative meetings now are challenging given remote operations, so big policy changes at this point will be difficult

Nursing—SCC and ARC; SCC completed more clinical hours earlier in the term prior to closure, but ARC did not; continued closure of clinical locations for an extended period will create more problems; work is being done to open the clinical locations again for students, with perhaps the requirement that students receive more COVID-19 training by the colleges before going to clinical sites

Fundraising-at the time of the Cabinet meeting \$114,576 for COVID-19 Relief Fund had been raised, plus another \$40,000 from Wells Fargo
