 - Adoption of Findings Related to Public Meetings and Social Distancing Recommendations Pursuant to AB 361:

BACKGROUND:

On September 16, 2021, Governor Newsom signed AB 361, which amended the Brown Act to provide local legislative bodies the ability to conduct virtual meetings under certain circumstances. The legislation included an urgency clause, which made it effective immediately.

AB 361 allows local legislative bodies to conduct virtual meetings during a state of emergency proclaimed by the Governor under certain conditions, including when "state or local officials have imposed or recommended measures to promote social distancing."

If the state of emergency is ongoing, the local legislative body must adopt certain findings by majority vote every thirty days in order to continue using the virtual meeting rules under AB 361.

On September 28, 2021, the Sacramento County Division of Public Health issued a "Teleconferencing Recommendation" memo, which provides in part:

Since March 2020, local legislative bodies, including commissions, committees, boards, and councils, have successfully held public meetings with teleconferencing as authorized by Executive Orders issued by the Governor of California. Using technology to allow for virtual participation in public meetings is a social distancing measure that may help control transmission of the SARS-CoV-2 virus. Public meetings bring together many individuals (both vaccinated and potentially unvaccinated), from multiple households, in a single indoor space for an extended time. For those at increased risk for infection, or subject to an isolation or quarantine order, teleconferencing allows for full participation in public meetings, while protecting themselves and others from COVID-19.

Utilizing teleconferencing options for public meetings is an effective and recommended social distancing measure to facilitate participation in public affairs and encourage participants to protect themselves and others from COVID-19. This recommendation is further intended to satisfy the requirement of the Brown Act (specifically Government Code Section 54953(e)(1)(A)), which allows local legislative bodies in the County of Sacramento to use certain available teleconferencing options set forth in the Brown Act.

RECOMMENDATION:

Consistent with the Sacramento County Division of Public Health's September 28, 2021 memo, It is recommended that the District Academic Senate (DAS) adopt the finding "that state or local officials continue to impose or recommend social distancing measures."

DAS President's Report

2. LRCCD Equivalency Committee-Regulation 5123-Second Reading

- b. Discussion included status of revision at different senates: ARC requested clarification from the district legal office and will continue discussing that response; SCC completed discussion on a third reading with multiple concerns, and is waiting for input from department chairs council and deans council prior to continuing the discussion; CRC discussion included the beneficial impact for adjunct faculty is in support of the proposed revision; FLC discussion included the interest in having thorough vetting of the detailed processes that would be developed if this regulation is adopted.

Discussion Items

1. ACUE Professional Development

- a. Review of the offering of the Association of College and University Educators (presentation sent separately)
- b. In addition to year-long course, micro credential sessions will also be available for faculty in LRCCD.

2. Equity Training Proposal from Work Group

- a. Report back from college academic senates regarding the work group's proposal for mandatory equity training for faculty. [shared as a separate document]
- b. Discussion included specifics about the rubric that evaluate how well the activity meets the requirement, concerns about the definition used, requirement to list amount of time, and other concerns about the logistics of the process.
- c. FLC senate voted to affirm the proposal, SCC senate voted to approve the proposal, ARC senate did not formally vote but expressed positive support, CRC senate is in support of encouraging the work group's proposal to move forward.
- d. DAS president will convey overall support for the proposal to SUJIC and express the concerns brought forward from the college senates.

3. Diversity, Equity, and Inclusion (DEI)

a. Time for reflection and discussion on how to infuse DEI work into everything associated with academic and professional matters.

Reports

- Meetings with Chancellor, Deputy Chancellor, etc.
 - Spring Convocation will have both virtual and on-ground option, with the hope that Fall
 2022 will be in person
 - Hiring process VPs will be meeting with district next week
 - Chancellor's Cabinet November 22 (virtual) and Board Study Session December 8 (in-person)
 with topics including enrollment management and dual enrollment
 - Online education DAS stressed the need for support for faculty including professional development, accessibility training and support, Fast Track, and resources to support online excellent pedagogy
 - Ethnic Studies FT faculty that we are hiring will need load though currently only one LRCCD course (from FLC) has been approved for Area F. In the event that other courses are not approved in a timely manner, discussion of possible solutions including to designate all courses as FLC 300 temporarily, to protect students who will need approved course for transfer. District is committed to success of Ethnic Studies departments at all four colleges.
- College Academic Senate Presidents
 - ARC working on courageous conversation community guidelines and considering designating the topic for a retreat rather than regularly scheduled senate meetings.
 - CRC continued to discuss FLC resolution for adjunct college service compensation in preparation for DAS discussion; concern for dual enrollment students that are being challenged by the online environment and the impact on the diversity of selected students; concern for accessible resources for online courses including courses using OERs or are otherwise ZTC; continued discussion on need for additional WEAVE confidential advocate position within the district to support students and employees suffering in environments of domestic violence.
 - FLC discussions of DO criteria for faculty prioritization v college criteria, discussions of faculty involvement in hiring processes for interim administrators; recognition that FLC does not have a process for evaluating dual enrollment programs and what faculty role should be in the establishment of programs, selection of faculty, and inclusion of equity throughout the process and programs.
 - SCC fourth reading on equivalency committee draft regulation; second reading on college mission, vision, values; continuing discussion on DO strategic planning re college goals, metrics, and indicators; FLC item on compensation for adjunct college service is an agenda item;
- District Equity & Student Success Committee (DESSC) (Anayah) (DESSC Report 11-16-21)
 highlights Sonia Ortiz-Mercado is new admin liaison, mentioned that DO is looking for outside
 consultant to streamline vaccine mandate process; Betty Glyer-Culver presented on the
 challenge on bridging the equity gap and factors contributing to loss of enrollment since
 pandemic conversion to remote learning; presentation on dual enrollment and advanced ed and
 note there is an advanced ed workgroup within DESSC; visit from DO project on Redesign of
 Enrollment and Financial AID
- District Curriculum Coordinating Committee (DCCC) (Giordano) no meeting since last meeting
- District Educational Technology Committee (DETC) (Trench) no meeting since last meeting
- Accessibility (DAPIC) (Knudson) captioning project working well but questions surrounding continuing funding; challenges to remediate OERs and searching for vendors; next pilot e.g. Canvas pages; still accepting faculty members for committee

• Ethnic Studies Council (Cheshire/Heningburg) – conflicting advice about requesting back-dating for courses after they are approved for Area F; questions about generation of FTE for Ethnic Studies FT hires – one per college; request that DAS support that new Ethnic Studies hires be designated as growth positions that will come with the necessary FTE. DAS reiterated the support for FTE for each of the FT hires.

Los Rios CCD Academic Senate Call to Action

Approved Tuesday November 17, 2020

The four Los Rios Colleges and the District Academic Senate support the Academic Senate of California Community Colleges (ASCCC) Fall 2019 Plenary Resolution "Support Infusing Anti-Racism/No Hate Education in Community Colleges". Specifically, to the following Resolved statements from that resolution:

- denounce racism for its negative psychological, social, educational, and economic effects on human development throughout the lifespan;
- take steps to not only strive for a greater knowledge about and the celebration of
 diversity but also to support deeper training that reveals the inherent racism embedded
 in societal institutions in the United States, including the educational system, and asks
 individuals to examine their personal role in the support of racist structures and the
 commitment to work to dismantle structural racism; and
- infuse Anti- Racism/No Hate Education in all its activities and professional development opportunities to the degree that doing so is feasible.

To achieve this, our Academic Senates are committed to:

- 1. Include a discussion of anti-racism/no-hate education on agendas. Remembering that we do not have to have an answer to start a conversation.
- 2. Prioritize culturally responsive curricular redesign with our curriculum committees.

- 3. Acknowledge, without assigning blame, that the structure of our colleges houses the biases and prejudices of their founding times. Those biases have privileged some and disadvantaged others, particularly African American and LatinX communities.
- 4. Prioritize the evaluation of hiring and evaluation processes with an equity lens.
- 5. Request services from the ASCCC about any of these topics if needed.
- 6. Evaluate our academic senates and find the voices among our faculties missing in governance. Find ways to empower those voices.
- 7. Work with our administrations, classified professional colleagues, and students to find constructive ways students can express themselves about structural and historical biases that exist.

Land Acknowledgements
