- Adoption of Findings Related to Public Meetings Pursuant to AB 361:

BACKGROUND:

On September 16, 2021, Governor Newsom signed AB 361, which amended the Brown Act to provide local legislative bodies the ability to conduct virtual meetings under certain circumstances. The legislation included an urgency clause, which made it effective immediately.

AB 361 allows local legislative bodies to conduct virtual meetings during a state of emergency proclaimed by the Governor under certain conditions, including when "the state of emergency continues to directly impact the ability of members to meet safely in person."

If the state of emergency is ongoing, the local legislative body must adopt certain findings by majority vote every thirty days in order to continue using the virtual meeting rules under AB 361.

RECOMMENDATION:

It is recommended that the District Academic Senate (DAS) adopt the finding "the state of emergency continues to directly impact the ability of members to meet safely in person."

- 1. District Accessibility Plan Implementation Committee (DAPIC) Recommendation-First Reading
 - Request for the DAS to advocate for the following, which was presented and discussed at the April 5, 2022 DAS meeting as a part of the end of year DAPIC report:
 - Ensure consistent leadership and or shared governance of district accessibility efforts long-term, inclusive of faculty and other constituency groups.
 - Faculty co-lead with reassigned time (0.2-0.4)
 - Administrative district office co-lead (AVC e.g. IT or instruction)
 - Faculty volunteers to include DSPS, DE, OCDC representation
 - Classified volunteers from DSPS
 - Close collaboration with district General Counsel
 - The group will be a DAS subcommittee

Discussion Items (15 minutes per item)

1. ASCCC Spring 2022 Plenary & Resolutions

Comment:

- Significant number of resolutions focused on antiracism.
- Disciplines list items all passed.
- Rising Scholars (prison and reentry) resolutions passed.
- DEI in Curriculum tool is spectacular and should be reviewed by curriculum committees at the colleges and district.
- Equity Avengers general session was refreshing with a message to 'take back our system',
 especially in terms of legislation. Ask for increased data collection, especially in addressing
 issues with equity gaps.

- Faculty hiring-enthusiasm for cluster/cohort hiring. Hoping that may be considered in Los Rios.
- Technical issues of the hybrid events were troublesome. Perhaps alternating between virtual one semester and in person another semester might be something for ASCCC consider.
- Encourage attendance at ASCCC Faculty Leadership Institute in Sacramento in June.

2. <u>LRCCD Employee Resources Groups</u>

- a. Follow up discussion regarding the input from the LRCCD employee resource groups
 - Might be useful to have DAS members act as liaisons to each resource group.

 Attending occasional meetings to listen or to ask for specific feedback on DAS items.
 - Request for DAS members who are also resource group members to help with this dialog.

3. Colleges Report Back on Past Topics

- a. Los Rios Colleges Online (LRCO) Report
 - Prior dates: Fri Feb 11th Executive Sponsorship meeting to review report; Tues Mar 1st shared at DAS, out for college review; Fri Apr 22nd Executive Sponsorship meeting
 - College AS Presidents will be sharing their feedback at the Feb 22nd LRCO meeting.
- b. Hyflex/Syncflex/Asyncflex
 - Tues Mar 1st shared at DAS, out for college review
 - CCCCO & ASCCC may be providing guidance in 2022-2023 on these terms.
 - SCC-Interest in the original hyflex work group making stronger recommendations.
 - ARC senate would like it to be possible for "individual faculty to exercise the academic freedom to voluntarily use the syncflex instructional format"
 - o CRC also wants the ability to use the modalities
 - FLC split vote between abstaining, yes, and no-so no strong support from FLC
 - Distinction between instructional format (in the class decision of faculty) vs instructional modality (scheduling/coding by admin).
 - SUJIC will explore this item more on Monday April 25th
- c. Academic Senate Travel Allotment
 - Tues Mar 15th shared at DAS, out for college exec team reviews
 - Tabled until fall 2022.
- d. Constitution & Bylaws
 - Tues Mar 15th shared at DAS, out for college review
 - After each college senate and/or exec team has discussed, the work group is to communicate about next steps and request agenda item by Wed April 27th for the May 3rd meeting.
- 4. Hiring Committee Composition & Hiring Outcome Data Review

- a. Discussion of the two data sets received from LRCCD HR. (shared as separate documents)
- Request was made to get the committee composition data broken out by college not just total numbers for the district. DAS will receive this as soon as they are able to get to it amidst faculty hiring needs.
- Request for HR to come and explain the data to the DAS at a future meeting.
- Interest in breakdown of admin, classified professional, and faculty numbers.
- 5. Inclusion, Diversity, Equity, Anti-Racism, and Accessibility (IDEAA)
 - a. Time for reflection on how to infuse IDEAA work into everything associated with academic and professional matters.
 - Encouraging registration in Black Student Success Week sessions. Friday has a black faculty focused session.

Los Rios CCD Academic Senate Call to Action

Approved Tuesday November 17, 2020

The four Los Rios Colleges and the District Academic Senate support the Academic Senate of California Community Colleges (ASCCC) Fall 2019 Plenary Resolution "Support Infusing Anti-Racism/No Hate Education in Community Colleges". Specifically, to the following Resolved statements from that resolution:

- denounce racism for its negative psychological, social, educational, and economic effects on human development throughout the lifespan;
- take steps to not only strive for a greater knowledge about and the celebration of
 diversity but also to support deeper training that reveals the inherent racism embedded
 in societal institutions in the United States, including the educational system, and asks
 individuals to examine their personal role in the support of racist structures and the
 commitment to work to dismantle structural racism; and
- infuse Anti- Racism/No Hate Education in all its activities and professional development opportunities to the degree that doing so is feasible.

To achieve this, our Academic Senates are committed to:

- 1. Include a discussion of anti-racism/no-hate education on agendas. Remembering that we do not have to have an answer to start a conversation.
- 2. Prioritize culturally responsive curricular redesign with our curriculum committees.
- 3. Acknowledge, without assigning blame, that the structure of our colleges houses the biases and prejudices of their founding times. Those biases have privileged some and disadvantaged others, particularly African American and LatinX communities.
- 4. Prioritize the evaluation of hiring and evaluation processes with an equity lens.
- 5. Request services from the ASCCC about any of these topics if needed.
- 6. Evaluate our academic senates and find the voices among our faculties missing in governance. Find ways to empower those voices.
- 7. Work with our administrations, classified professional colleagues, and students to find constructive ways students can express themselves about structural and historical biases that exist.

Land Acknowledgements

ARC Indigenous Land Statement

"We acknowledge the land which we occupy today as the traditional home of the Maidu and Miwok tribal nations. These sovereign people have been the caretakers of this land since time immemorial.
