- 1. Call to Order K. Corbin called the meeting to order at 2:32 PM.
- 2. Approval of Agenda The agenda was approved by consent.
- 3. Approval of Minutes The minutes from the January 27, 2015 meeting were approved by consent.
- 4. Announcements/Updates
 - a. New members David Redfield (ARC) joined DCCC.
 - b. Guests None
 - c. Announcements: Sue Lorimer stated her review of the colleges' self-studies reflects the good work done by LRCCD Curriculum Committees.
- 5. Competency Committee Report
 - a. Reading Competency (Chair: Shihni Giedd, CRC): No report. The following courses are awaiting review.
 - i. SCC PHIL 306 Environmental Philosophy
 - b. Math Competency (Chair: LeLe Trieu, FLC):
 - i. The Math Competency committee granted temporary approval of two courses, ECON 310 at CRC and MATH 121 at SCC, until Spring 2016. They also plan to re-evaluate all courses approved for math competency in Spring 2016 using only their course outlines of record. After some discussion, the DCCC committee agreed that the approval of the two courses need not be temporary, but rather be unconditional, as the same criteria will be used to re-evaluate them in Spring 2016. Furthermore, before taking on a re-evaluation of all courses approved for math competency, the chair of the Math Competency committee should appear at a future DCCC meeting to explain the rationale. Comments from DCCC members included
 - re-review sets a dangerous precedent

- courses not re-approved should be given a "warning" and recourse measures before removing approval

- 7. DAS Senate Report
 - DE DAS requests that local Curriculum committees discuss and approve the recommended changes to the DE section of Socrates (see item 8 below) and notify their Senate President before the changes are made.
 - Reading Depts: DAS will discuss at their next meeting a plan to bring representatives of Reading together with Curriculum Chairs to discuss coordination, limits, etc.
 - DE Policy: A second reading of the revised DE policy is scheduled for the next DAS meeting.
 - District Committee Structures: DAS plans to look into the structure and membership of District committees, especially the District IT committee, in the near future.
- 8. SAG Report from February 27 meeting
 - DE Fields The separate homework and evaluation methods sections for DE will be removed. Choice of modalities will also be removed. Rather, if "Distance Education" is selected, the developer will choose the maximum percentage of contact hours (25%, 33%, 50%, 67% or 75%) that will be through distance education. Developers may set additional limits to the DE modality if desired. The COR will include a statement regarding regular and effective faculty-directed contact.
 - "TV" DE courses P. Smith will run a query to find any courses that have selected the "TV" modality. That modality should be immediately removed from those courses.

Note: this refers only to the TV modality, not Interactive TV. The non-interactive TV modality is not Distance Education; it would be considered correspondence.

- AO Reporting Needs P. Smith will continue to develop new reports useful for Articulation Officers after completing the DE changes.
- Requisite Reports After a discussion of potential requisite reports, it was agreed that the instruction offices should produce a detailed list of the data needed for CCCCO reports regarding requisites.
- New-to-District/New-to-College SAG agreed that when several colleges are developing the same new course, the first one to DCCC status should be re-designated the "new-to-district" course to prevent potential troubles.
- 9. Distance Education
 - a. Defining "fully online" DCCC declined to define this term, as different sources (state, federal, etc.) define it differently.
 - b. ADA accessibility & Pearson products Pearson is working on the ADA accessibility of its educational software products. In the meantime, faculty should be trained to understand the limits of these products and potential work-arounds.
 - c. Level of specificity in COR DCCC agreed that the level of specificity, for example whether or not to include "proctored exams" in the COR, should be left to the discrepancy of the local curriculum committee. However, it is a good idea for DE committees to encourage/recommend instructors to state in their syllabi how they will be doing regular and effective contact for the course.
- Title 5 Changes to Repeatability: Music Courses Report from the 2/27/2015 meeting.
 K. Corbin and most of the curriculum chairs met with representatives from the local Music departments.
 - Several MUIVI courses will be put into families
 - Applied Music courses will not be put into families
 - Ensemble Classes These are limited to four enrollments, but some transfer universities require music majors to be enrolled in an ensemble class every semester in college. This is a problem, as many students take longer than four semesters to transfer. CCCCO states that districts may allow additional repeats, but will not receive apportionment. LRCCD will review these on a case-by-case basis, and will allow additional repeats when necessary and reasonable.
- 11. Other
 - a. Course Designator/Thematic Block form The revised Course Designator was approved (MSP R. Yang, D. Pease) and should now be used by local committees.
 - b. Noncredit Regional Meeting: Friday, March 20, 2015, 9:30am-2:00pm, Foothill College in Los Altos Hills (South Bay). Representatives from LRCCD are encouraged to attend. It was stressed that LRCCD is not seeking to move existing courses to non-credit, nor is it seeking Adult Education.
