At the meeting with the Chairs, Kirsten reminded the Writing Competency Committee Chair that the following two courses must be reviewed for the November 20 DCCC meeting.

- iii. SCC ENGWR 488 Honors College Composition and Research Has been catalogued since F14; need competency committee review ASAP.

7. Curriculum Proposals:

a. Courses/Programs by College

All Courses/Programs are organized by college and listed at the end of this agenda:

ARC programs: moved (Dyan Pease), seconded (Steven Boyd). Passed unanimously.

CRC programs: moved (Eric Wada), seconded (Dyan Pease). Passed unanimously. FLC programs: moved (Bill Simpson), seconded (Marie Schirmer). Passed unanimously.

SCC programs: moved (Brian Noel), seconded (Dyan Pease). Passed unanimously.

b. Status of Collaboration Requests—See handout (Appendix A) for the status of collaboration requests as of October 29.

Ready to Move: ENGLT 340 & 341, MUSM 495, SPORT 351

ENGLT was held up at ARC due to a Socrates glitch: the developers last name has an apostrophe, which conflicted with some of the code, which uses apostrophes. The problem has been fixed.

Also, ECON 310 was up for collaboration but was somehow deleted. Only the DCCC Chair should be able to delete. Kirsten did not delete; she will follow up with Phil (as well as with the developer) to find out how it was deleted.

- c. Course Designator/Thematic Block Forms
 - i. First Reading
 - 1. FLC IMAGE (Thematic Block) The Curriculum chairs at each college have been contacted; everyone is onboard.
 - ii. Second Reading
 - 1. CRC ESL P (Thematic Block)—see below.
 - 2. CRC ESL R (Thematic Block)—see below.
 - 3. CRC ESL W (Thematic Block)—There is some concern (and possible misunderstanding) regarding this proposal. CRC wants to open up 100-level thematic blocks in ESLP, ESLR, and ESLW; this thematic block already exists in ESL, ESLG, and ESLL. ARC is concerned that proposed courses in these blocks will confuse prerequisite checking, especially when the automated prerequisite blocker is activated. Kirsten will follow up with ARC and CRC ESL department chairs and deans. For now, the proposals are on hold at second reading status.
 - 4. SCC MATH (Thematic Block)—Moved to approve (Dyan Pease), seconded (Eric Wada). Passed unanimously.
 - iii. Information Items
 - 1. New FITNS Family: Dynamic Fitness
 ARC is developing a "Dynamic Fitness" family of courses. ARC believes the family of courses does not duplicate course content from other courses. One other college is also developing a course that would fit under this new family.

This is the first time we have created a new family since the initial implementation of families, so we do not yet have a process for how to do this. This needs to be verified as these courses (if there were duplication) could affect enrollment limits for students should they take similar courses at the other colleges. Need to make sure the department chairs at the other colleges are on board with the proposal. In the meantime, the committee appreciates the work done by ARC in contacting the other department chairs to make sure there were no concerns about the new family and supports creating the new family. Also, it was suggested that Socrates be modified so that department chairs at all colleges are notified when new family requests are initiated. Kirsten will bring up at SAG.

8. DAS Senate Report – 10/6 and 10/20

- Kirsten and Brian met with reading and writing competency chairs and discussed what constituted a quorum and whether quorum was needed at competency committee meetings. Documentation is lacking. If quorum is required (unknown), can opposing members filibuster simply by not attending the meetings? They also discussed whether previously approved courses need to be re-reviewed periodically.
- Two colleges (ARC and SCC) are waiving Ethnic/MC requirements for students who have Bachelor's Degrees. Board Regs indicate that the Ethnic/MC requirement is separate from and in addition to GE requirements, so it is unclear whether it is OK to waive the requirement. FLC would like to waive as well.

9. SAG requests/report

- The group continues to discuss AO screens; there are still some bugs. Need alignment of AO practices on how to note in Socrates courses submitted for UC/CSU approval.
- Some departments are creating new designators for existing courses due to a lack of numbers. However, when the existing courses are migrated to the new designator, the same numbers are used, which seems inefficient. If the interest is to increase numbers, why not start at the beginning in the new designator, build from the bottom, with new thematic blocks.

10. Music Courses Families Update (see Appendix B)

- Historically, only a few of these music courses in the District have been offered as repeatable, so should they still be considered active participatory courses?
- Need to get support from CSUs and UCs: Got two letters of support; UC state there
 is difficulty of getting them through in four semesters once get to UC if piano
 proficiency is not there
- In three areas (voice, piano, applied), students at CSU absolutely need four semesters, or won't get a certificate or degree. Thus, if all the classes in one area are in the same family, it is possible some students will not be able to get four semesters. This provides a rationale for having two families in each of those three areas.
- Jamey mentioned trying to connect with Pam Walker about changes to the threestrikes rule.

11. Automated Prerequisite Checker

No report—meeting next Friday.

12. Updates from the District

- The latest PPC list will be distributed soon along with the schedule. Several convergences are expected in the spring.
- Examining Phil's workload to determine reassign time. Looking into possibility of resurrecting deleted programs. Could be spring conversation to determine faculty interest.
- Reordering elective subgroup courses in programs is not easy to do. Working on it.
- Computer Science ADT: some colleges outside the district have them, so there will be pressure on us to have them too. Problem due to high unit math and CIS courses. It was suggested that there are not many completers for existing CIS degree programs and that deleting them might affect only a few students. On the other hand, the current numbers may not be accurate since students can transfer and complete the program once they transfer. In other words, the CSUs are accepting these students before they are "ready," and students are willing to go into the CSU early because of the high salaries offered upon graduation. In addition, providing a clear transfer pathway (ADT) might result in more program completers. One solution may be to convert 4 unit CIS courses into two courses, one with 3 units of lecture (C-ID compliant) and the other with 1 unit of lab; they could be offered with concurrent enrollment required.

13. Other

- a. Independent Study—Follow up from September (see supporting document)
 - The committee agrees that 495 "Independent Study" courses should be lab only. All four colleges should revise their courses so that they are LAB only. The unit values should remain unchanged for now.
- b. Competency Committees
 - i. Meeting on October 27—Report
 - ii. Reviewing courses already approved for competency—Decision item
 - Addressed in Item 8, above. Ongoing discussion since May. Is there interest to have competency committees re-review previously approved courses?
 DCCC will discuss at November meeting. DCCC will also discuss competency committee quorum rules.
- c. Process for Adding New Families
 - Addressed above in Item 7.c.iii.1. There is currently no process.
- d. Streamlining Approval for CTE Programs and Courses (see supporting document) Discussion postponed.

- (*) Both of our neighboring CSU and UC Music Departments have written letters of support regarding their concernover the lack of repeatability in the Los Rios skills classes, specifically citing voice, piano, and applied music. It is necessary for students to COMPLETE the four- semester sequence in lower division.
- ! CRC and SCC would still like to push for four families within traditional voice, or at least three, with headings such as "Diction", "Repertoire", "Style", "Performance Practice"
- \emptyset ARC needs to guarantee that our traditional voice and jazz voice students can complete the four-semester sequence in order to complete the studio voice and jazz/pop studio voice certificates
- # Music majors need to complete the four-semester traditional piano sequence in order to satisfy the piano competency requirement at CSU. CRC and perhaps other colleges may be implementing higher levels of piano, and/ or "piano for music majors"
- @Applied students need to guarantee passing the four-semester sequence of applied music to complete the AA and AA-T. ARC may be exempt from putting applied music into families since it has never been repeatable there.
