- I. Call to Order The meeting was called to order at 2:35 PM.
- II. Approval of Agenda The agenda was approved by consent.
- III. Approval of Minutes from October 27 meeting The minutes were approved by consent.

#### V. Competency Committee Reports

- A. Reading Competency (Chair: Tracy Rauschkolb, FLC): The Reading Competency Skills Committee recommended denial of CRC SOC 305 and approval of ENGRD 311. A motion was made and seconded (Gilman/Yang) to accept the recommendation. Members of DCCC were concerned that there was insufficient evidence that the approved rubric was used to make this recommendation. The motion failed by a vote of 3 Aye, 7 Nay with 2 abstentions. DCCC recommends that the Reading Competency Skills Committee provide DCCC with completed rubrics for the two courses clarifying reasons for approval/rejection and in the case a course is rejected, recommendations to the developer for revision to improve future chances.
- B. Math Competency (Chair: Jean Vrechek, Joseph Steever, SCC): DCCC unanimously voted (MSP Yang/Medina) to accept the Math Competency Committee's recommendation to approve MATH 135 (SCC).

- C. Status of Collaboration Requests JOUR 350 is complete and can be catalogued.
- D. Course Designator/Thematic Block Requests
  - 1. First Reading GENSCI 90-99 (ARC). There was a motion to suspend rules to consider GENSCI 90-99 at second reading (MSP Pease/Fowler). It was approved unanimously (MSP Yang/Fowler).
  - 2. Second Reading INDIS 320-9 (SCC) was approved unanimously (MSP Yang/Fowler).
- VII. Updates from the District (Nye/Garcia) The AB705 kick-off meeting went well, with over 75 participants. Implementation teams at the district and college levels are being formed, with plans for full implementation by Fall 2019.
- VIII. DAS Report (Lopez) LRCCD participated in a Meta-majors discussion at Sierra College. There is interest in bringing folks working on Pathways and Meta-majors at the colleges together, but some were uncomfortable with this. DO acknowledged that different colleges are at different points in the process, and that we don't want to slow progress, but to move forward in a coordinated way.
- IX. SAG Report (Gilman/Noel) Certificates in the 12 18-unit range are currently only called "Certificates of Achievement" in Socrates. SAG discussed that they really should be called "Certificates" until state-approved and then they can be called "Certificates of Achievement." Lynn pointed out that the rules are changing about the unit level on certificates and requirements on being submitted to the CCCCO. Jamey reminded the committee that LMI information is going to be required no matter how low the unit level is. A discussion ensued regarding "C-minus" grades transferred to Los Rios from other (not CCC) colleges. DCCC agreed that Los Rios should NOT round up C-minus grades, as it would artificially inflate GPA's. Work Experience course repetition was also discussed at SAG, with the agreement that the current petition process is sufficient.
- X. Decision Items- PPC Process. The proposed PPC process was discussed. Issues included:
  - Number of meetings Is four sufficient? There is a process included for emergencies, which might include grant funding, state initiatives, etc.
  - Minutes In this proposal, minutes are only taken at the convergence meeting. There
    was some concern regarding this, but it was explained that the process is still by
    consent up to the convergence meeting, so no minutes are required at the
    informational meeting.
  - Removing programs from the list The committee recommended a line be added regarding removal of programs if no longer desired.

The committee voted unanimously to approve the process with edits and to forward this recommendation to DAS (MSP Lopez/Pease).

### XI. Discussion Items

- A. Class Size Max on COR This item was tabled for the January 26 meeting. DCCC does request that representatives of DAS in favor of the inclusion of class size maximums on the COR be invited to that meeting to provide input.
