I. The meeting was called to Order at 2:35 PM.

- IV. Announcements/Updates
  - A. Introductions, New members, Guests
  - B. Note taking at DCC this spring: 1/26 (ARC), 2/23 (CRC), 3/23 (FLC), 4/27 (SCC)
  - C. Announcements: Michael Lawlor is now the interim Dean at the Elk Grove Center so Dyan Pease is taking the role of DCCC Chair a semester earlier than planned.

There was discussion about the current process and it was suggested by Lynn Fowler that the DCCC might want to require the competency committees to provide the completed rubrics along with the recommendations to deny or approve competency requests. Dyan said she would ask get more information on process from the DAS.

# B. Courses/Programs by College

All items were approved.

ARC: MSP Wada, Ahmadi, unanimous approval

Discussion about changes with FIRE at ARC. Fifty-four courses will be majorly overhauled. It was decided to keep the outlines as revisions as long as the content has not significantly changed.

CRC: MSP Fowler, Gilman, unanimous approval

- C. Status of Collaboration Requests Many of the collaboration requests have been in process for a long time so the group discussed each one. ACCT 341 was requested in March, 2017. All four colleges are still at draft. Dyan asked the Chairs to check with ACCT faculty to find out if they still want to collaborate on this course. CHEM 306 is moving along nicely except at CRC. Brian said he would check with the developer at his campus. CISA 308 is a collaboration between ARC (outline at TR) and CRC (outline is at draft) Brian will check on this one as well. CISS 315 is at DCCC status for both SCC and ARC and was approved. Chairs will catalog CISS 315. FITNS 412 is a collaboration between ARC (at TR) and SCC (at Draft) Dyan said she would check with Connie Zeurcher on this one. PHOTO 370 and 372 are both at DCCC for SCC but still at TR for CRC. Brian will check with the developer at CRC. Finally, CRC and SCC are both at Draft status on SPORT 318. This collaboration was initiated in May, 2017. Dyan will check with Connie Zuercher and Brian will check with the CRC developer to see if they still want to collaborate.

  - 1. The new ARC designator and thematic block (ESLA) had first reading. There were no concerns.
- VII. Updates from the District: Jamey provided an update from the district. He shared information about the AB 705 meetings. He reported that English is ready to implement and will use self-reported GPA for placement of students in English 300 or in one level below transfer + coreq. Math is in process of developing a plan. ESL hasn't met yet. Reading has met and is developing a plan.

#### XI. Discussion Items

### A. Class Size Max on COR:

Alisa Shubb and Shannon Mills represented the DAS with the request that the DCCC develop a set of criteria that could be applied when faculty want to request a class size maximum on the COR. Various members of the DCCC expressed strong concerns. Many on the DCCC feel that this is a union issue and the LRCFT would need to be involved with discussions about adding class size maximums to the COR. LRCFT needs to be involved because we could potentially be putting ourselves in trouble with accreditation if we cannot meet the requirements of our own CORs Others feel that class size maximums are a scheduling issue between faculty and Deans and, as such, do not belong on the COR. Still others voiced concerns about the process that got us to this point. It seems we have moved from "exploration" of the idea to "implementation" of the idea without a clear set of records showing the process of decision-making. Some courses in Los Rios have specified class maxes in methods of instruction section in the COR. Faculty have expressed that they do not want F2F and online sections to have different caps. Facilities could be reason why there is class cap. The DCCC requested further discussion and clarification at the DAS on February 6, 2018.
