- I. The meeting was called to order at 2:30 pm.
- II. Approval of Agenda: Brian Noel added a couple of outlines (HIST 485 and HONOR 366) to the curriculum proposal list for consideration. Agenda was approved by consent.
- III. Minutes from February 23, 2018 meeting: approved by consent
- IV. Announcements/Updates

#### VI. Curriculum Proposals:

- A. Families Update: Kinesiology faculty in the district will meet in April to identify families for courses in their area. Dyan will report back on progress.
- B. Courses/Programs by College (All Courses/Programs are organized by college and listed at the end of this agenda.)

ARC: FITNS 416 should be held pending adding the course to an existing enrollment family. Motion to approve all but FITNS 416: Fowler; Second: Ahmadi MSP

CRC: KINES 460 may impact Sociology, so have discussions between the departments occurred? Motion to approve all but KINES 460: Medina; Second: Fowler MSP

FLC: Motion: Noel; Second: Medina MSP SCC Motion: Fowler; Second: Ahmadi MSP

- C. Status of Collaboration Requests: There has been some movement on collaboration requests but none are ready for DCCC vote. Chairs agreed to nudge developers at their colleges.
- D. Course Designator/Thematic Block Requests
  - 1. First Reading CHEMT New Designator Request (SCC)
  - 2. First Reading ENGLB Thematic Block (CRC)
  - 3. First Reading ENTR New Designator Request (SCC)
  - 4. First Reading MAKR Thematic Block (SCC)
  - 5. First Reading MATHS New Designator Request (FLC): Why not a 90-level course? These courses will not count towards financial aid eligibility (30 units can be discounted). 300-level support courses also do not have a transferable counterpart.
  - 6. First Reading STAT Thematic Blocks (FLC): All of the available thematic blocks are being designated as support courses. Is this necessary? FLC will work with developer to revise request.
  - 7. Second Reading ENGRD 90 99 Thematic block (ARC)
  - 8. Second Reading PACT 430 439 Thematic block (ARC) Motion to approve ENGRD 90-99 and PACT 430-439: Fowler; Second: Medina. MSP
- VII. Updates from the District: AB705 update: The district is taking a wait and see position until Los Rios has further guidance on curricular issues. District is suggesting that we wait until we get clearer guidelines before deleting any existing curriculum. Lynn Fowler asked Tammy if AB705 affects intersegmental prerequisite requirements. The UC may decide to drop articulation because the UC requires certain prerequisites to be in place.
- VII. DAS Report: The DAS is waiting to have a discussion about GE patterns because as of yet there are not two colleges expressing interest in the discussion. The FLC Senate voted to kick the issue to the Curriculum Committee and the FLC Curriculum Committee voted to move it back to the Senate. CRC mentioned that at CRC the Academic Senate had the discussion on its agenda that day. It was noted that 22 community colleges in California allow students to choose which GE pattern they will follow.

SAG Report: The Socrates Advisory Group continues to work on important updates and fixes. Phil is currently working to change the "Classification" section of the program outline to the "Goal" section. Under *Classification* the developer could choose one of five options: Transfer, Apprenticeship, Career and Technical Education (CTE), Both Transfer and CTE, or Other. Under the new *Goal* section the developer will choose among three options: Transfer, CTE, or Local. As program outlines are opened for revision the

developer will be required to update this section. There is still an ongoing issue of SCC faculty disappearing from Socrates.

#### VIII. Discussion Items

- A. Reading Competency (Kate Jaques): The discussion was basically to gather information about the requirement. Board policy was reviewed, data gathered from LRCCD colleges and the state were shared. AB705 may have some impacts on this requirement. Reading faculty would be retrained in other disciplines. As a discipline, there is still a need for reading courses to help students who are not prepared for college-level work. Program maps cannot include the reading requirement easily because of the many ways the requirement can be met. Data suggest that students are leaving without degrees with just the reading competency requirement outstanding. Statewide data: 49 community colleges use 1st semester college writing to meet the requirement. 22 use GE patterns. 31 do not have a specific requirement identified in their catalog. 22 colleges have reading departments, and not all have a separate class for reading competency. DCCC's role is where the discussion about reading competency should occur.
- B. *Eligibility for* statement in the prerequisite (Lynn Fowler): Information will be forwarded to DCCC members.
- C. Should Los Rios pursue having an organized approach to numbering co-reqs for AB705? (SAG) This item was not discussed.
- D. PPC List Review by Colleges; Process for informing the vote. Dyan asked the chairs to consider how the DCCC chair will be informed by curriculum committee input before she and the AS President vote.
- E. GE Patterns: At this time we do not have two colleges interested in opening the discussion at AS to propose a change to Los Rios GE pattern requirements.
