- II. Approval of Agenda – Approved by Consensus
- III. Approval of Minutes from January, 2020 meeting – Approved by Consensus
- IV. Announcements/Updates

 - POLS 382 (CRC): Approved February 26, 2020 (Vote: 7 – 6 in favor) Lynn motioned to accept the Competency Committee’s recommendation to approve POLS 382 for Math Competency, Valerie seconded the motion, approved unanimously.

ARC – Roxanne motioned for approval, Lynn seconded the motion, approved unanimously.
CRC – Lynn motioned for approval, Renee seconded the motion, approved unanimously.

FLC – Lynn mentioned that NURSE 100 requisites are not in alignment with NURSE 100 at ARC, but the requisite at ARC is fairly recent. – Valerie motioned for approval, Lynn seconded the motion, approved unanimously.

SCC – Lynn motioned for approval, Roxanne seconded the motion, approved unanimously.

- a. Second Reading: SCC: CISM new designator and thematic block request – Valerie motioned for approval, Renee seconded the motion, approved unanimously.

VII. Updates from the District – Torence Powell: No updates

VIII. DAS Report - Alisa Shubb: Ally accessibility tool implementation for all Canvas courses being discussed. Low cost course materials initiative passed. 90% Course enrollment change has been reversed back to previous process. Meetings occurring regarding Online Education within Los Rios. AB-705 Workgroup exploring options for students who successfully complete a support course, but not the parent course. One option discussed was non-credit, so there will be ongoing discussions throughout the district regarding the exploration of non-credit. Discussion around advisories and requisites in light of curricular changes due to AB-705.

IX. SAG Report – DO working on a digital catalog. Katrina Harmon has a spreadsheet of issues from SOCRATES XML extract. Some of these may be technical issues, others may require curriculum action. Phil Smith will go through list first. Discussion about adding CB25 and CB26 codes to SOCRATES. Phil can add these but that won't create an automatic rollover of this information into PeopleSoft. Discussion around moving catalog start date to August.

X. Discussion Items

A. GE Alignment Project Update – Email went out to all faculty from Dyan and Julie Oliver. Each Curriculum Chair and AO team has taken a set of courses offered online with CSU articulation mis-alignments. Team will review course outlines to determine how best to handle mis-alignments and then contact department faculty. A scope of work document is being drafted to help support ESA reimbursement for this work. Cross-district discussions may need to be facilitated for some courses/disciplines.

B. Student choice of any of the three GE patterns (Suggested language) – There is no intention to remove local GE requirements [i.e. III(a) & III(b), and V(a) & V(b)] Students wishing to pursue a local degree and transfer would still need to pay attention to both patterns. Discussion around the proposed language – recommendation to add the word 'local' in front of graduation requirements. Alisa asked about potential need to revise program maps. Since students will have options, it will be up to departments to decide if program maps should reflect a specific GE pattern, or include courses that meet all three patterns, etc. Michael noted that the words 'General Education' are missing from IGETC. There is a dropdown in SOCRATES for GE requirement – may need

to watch this as programs come through to revise to show all three options. Next step will be for recommendation to go to DAS (where it will go down to the local Academic Senates for feedback / decision, and back to DAS). Alisa motioned for approval with the minor edits as suggested, Renee seconded the motion, approved unanimously.

Lynn’s findings regarding Ethnic/Multicultural Studies: Current language in 2.5.1 does not seem to be aligned with Title 5 requirements because it allows the requirement to be filled by a course in the major or an elective. Lynn’s suggestion is to simply remove this statement from the end of the sentence in 2.5.1. Upon further discussion, it appears that the current language simply provides greater flexibility in meeting our additional graduation requirement and does not undermine the Title 5 language, and as such no change is needed. Lynn believes that it may still be wise to move where this graduation requirement is listed so it does not appear to be part of the local GE pattern. This will be a future agenda item.

- C. C minus issue (Suggested language) – Lynn and Shannon are proposing an additional sentence to P-7241 2.2.1 to address C- grades. In addition, a recommendation is being made to revise 4.1.1.2 to address the need for a ‘C’ or ‘P’ grade (not a C-) for ADTs. Eric mentioned the importance of acknowledging that the P from another institution must be equivalent to at least a C (not C-). Alisa suggested a slight edit to the language proposed to indicate that the C- constitutes satisfactory completion in the major. This topic will come back on our next agenda to ensure the language is correct.
- D. Catalog year start date: an issue because currently the new year starts with summer session but new articulations do not take effect until fall (Tammy was to take this issue to VPI discussion table.) – There was discussion about this at the VPI level but it is still being investigated.
- E. Advisories and requisites in a post AB-705 world (Lynn) – Some advisories are no longer relevant as the courses are not being offered. Some requisites must stay in place for articulation purposes. Eligibility for statement may still be valid for advisories and requisites, but justification as a requisite is problematic without a course to point to. As courses are deleted, it will no longer be possible to reference course SLOs to justify requisites. Alisa mentioned that she thinks there is a real need for uniformity in how this topic is handled.
