X. SAG Report

- A. Discuss Emergency Addendum in Socrates and local college considerations for workload/workflow.
- B. We've already presented to the state that we will convert and need to continue with an addendum for spring (and beyond).
- C. The addendum covers emergencies from the entire semester to two week hiatus for smoke. Faculty are still raising the question of what is an "emergency?" We need a toggle switch in Socrates; how permanent is something in Socrates? Should there be a time limit on the closure? How can faculty be assured that an emergency conversion occurs in a feasible manner? Having flexibility is so important; could there be a dialog box to include limitations? The COR is faculty purview, the COR can't have fixed wording in this case there should be an option to select no, but understand "selecting no" has ramifications.
- D. Have it as a statement in an emergency situation that curriculum chairs control. Default is yes, but if departments want to remove it in the future, then can click on no.
- E. Faculty would have to come to curriculum committee, in conjunction with AS, makes the decisions to uncheck the button.
- F. Next steps: MOU from DO on collegial consultation during emergency situations. Approved by DCCC and DAS. This MOU also outlines the "opting out" procedures.
