IX. Discussion Items

A. Regularizing GE/prerequisite review (A. Shubb)

Suggests have a local curriculum process to review courses to see if they are in alignment with the other colleges in the district. Asking developers, "Is it shared? If so, have you checked if GE and pre-reqs are aligned." Conversation about revising rule of 5. One challenge is multiple reviewers so the same course could be approved or denied for GE. Think about how we would look for these at a local level. At the same time how would DCCC flag these issues and are we going to take a stand on the rule of 5 and take it to District senate. Become a develop item.

- B. Catalog rights workgroups presented out by Torence Powell
 - Catalog effective dates
 Trying to catalog updates. Look at June 1 deadline. Also involves registration.
 Have decoupled summer and fall semester. Want to release registration earlier. Can pull data that is not current. Suggested to push effective date from June to August. Need faculty and AO representation.
 - ii. Catalog rights definition and application across the districtWorkgroup formed to better define this and implement this into the system.
- C. Course equivalency workgroup

There may be some inaccuracies in PeopleSoft which feeds into systems like Degree Planner. How do we define equivalency? Rule of 5? Etc. Looking for volunteers to work on this group. Workgroup Files - Google Drive Similar/Cross-listed courses in the district and Degree Planner Similar to course equiv. Same workgroup.

- D. CPL guidance and local implementation presented out by Torence Powell Credit for prior learning not a priority but if possible would like to continue movement on this item. Looking for anyone who is interested from the campus.
- E. GE alignment project: Update on progress, and identify next steps

Update: Lynn Fowler (AO) was the lead on this who recently retired. Looking for a new lead on this. May place a pause on this project until we get a clearer definition on what equivalency is.

F. Continue equity/anti-racism in curriculum discussion

FLC – Going more of the professional development route so it happens before it gets to curriculum and allows the discussion to happen at the expert level. Faculty developed a rubric to help faculty think about equity while creating curriculum. anti-racism-equity-and-curriculum-handout.pdf (losrios.edu)

SCC – Created an equity sub-committee happens before tech review. Have a list of those on program review. The committee goes to departments and speak with them equity framework on the front end of curriculum. Academic senate approved sub-committee. Another small way to help with equity as well is to consider OER for textbook options.
