A. Required language for ADT to include minimum grade of "C" (or "P) for each course in major (Morgan): Put the language into the description as a workaround for approval, also add in program narrative; will be addressed at SAG; might we vote on this at DCCC to ensure SAG addresses

Motion to accept that the boiler plate language at the bottom of ADTs is changed from minimum grade of C to minimum grade of C or P for each course in the major in Socrates. Brian moved first. Rene moved second. Motion approved.

- B. GE alignment project: update on progress, and identify next steps (standing item): No discussion
- C. Catalog Effective Date Workgroup: Michael Lawlor reported
- D. Math: Trying to get MATH 333 approved by Board in time for Fall registration. This course needs to be approved for at least one college. Cutoff date for going to the Board is March 8. Latest date to be approved at DCCC would be March 7.

Another unresolved issue is the placement tree. Angie has created a draft.

Another issue is addressing language regarding placements that goes to students, including automatic messaging.

Clear communication to counseling is also needed.

Intent of MATH 333 is to meet B4. It will meet competency, but it won't need to, because the STEM track students will be taking other courses that meet competency. The goal is to meet the needs of B STEM students who would have normally been placed into MATH 120. Hoping for retroactive approval.

- E. CID MATH 150. Should MATH 333 seek to align with this or not? Benefits—if you want to add course to ADT, it could. Also facilitates articulation to four-year. Prerequisite of intermediate algebra will prevent it from getting approval.
