- B. Status of Collaboration Requests: Dance 498 can go to Board by FLC and ARC.
- C. Course Designator/Thematic Block Requests: ARC has a number of Humanities courses (which were in the Phil. department) that they would like to move to the Religious Studies (RLST) designator. William Lester, "enthusiastic Humanities professor" wants to develop this program with the new thematic blocks. CRC currently has this designator with one course in it. There is no desperate need to do this today, but Professor Lester wants 5 courses to move over the RLST designator. Rene M. moved to suspend the rules to allow a vote on ARCs request for the new thematic blocks. Brian Noel seconded the motion. The motion to suspend the rules to do two readings in one meeting passed unanimously. Rene M. motioned to move this request through, and Al Ahnadi seconded the motion.

A. Guidance for Virtual Meeting

Adoption of Findings Related to Public Meetings Pursuant to AB 361:

BACKGROUND:

On September 16, 2021, Governor Newsom signed AB 361, which amended the Brown Act to provide local legislative bodies the ability to conduct virtual meetings under certain circumstances. The legislation included an urgency clause, which made it effective immediately.

AB 361 allows local legislative bodies to conduct virtual meetings during a state of emergency proclaimed by the Governor under certain conditions, including when "the state of emergency continues to directly impact the ability of members to meet safely in person."

If the state of emergency is ongoing, the local legislative body must adopt certain findings by majority vote every thirty days in order to continue using the virtual meeting rules under AB 361.

RECOMMENDATION:

It is recommended that the District Academic Senate (DAS) (DCCC) adopt the finding "the state of emergency continues to directly impact the ability of members to meet safely in person."

Roxanne Morgan moved to accept the motion that we continue to meet virtually. Al Ahnadi seconded the motion. Roxanne asked what will happen to the Brown Act in fall. A. Hicks understands that according to the District Senate that as long as the state of emergency stays in effect at the state level, that we will stay virtually. If it is overturned at the legislative level, we will need to go back to meeting in person.

XII. Discussion Items

A. Training chairs and term length/release time
Rene M. reported that we should put something together to help new chairs,
specialists and AOs, such as a curriculum calendar- what the chairs and AOs do
and when. CRC has changed default years to 3, instead of 2. For the 1st half of
the chair's term, the former chair is the vice-chair. ARC has a vice-chair. Rene
wants to send out a shared document that all chairs can add to help in coming
curriculum folks. This idea had support. Rene suggested that we have a similar
document for the DCCC chair.

- B. New Ethnic Studies requirement and matching Board policy/regs
 Rene M. says the COR competencies are not out yet but should be out soon for
 the new Enthic Studies requirements for all community colleges. They will be the
 same as CSUs and UCs. The problem is that Los Rios already has an Ethnic Studies
 / Multicultural requirement that is in Board Regs. This will need to be removed /
 revised? Who starts this conversation? AOs? Academic Senate? If we need to
 mirror what is going on at CSUs, then only the 5 Ethnic Studies courses would
 qualify. That is based on Los Rios not wanting to cross-list. We have changed
 Board Regulations before. How do we do it? B. Noel says in the past we vetted it
 here, and then it goes to DAS. This should go on the list for next chair of DCCC.
 Shannon G. shared the following: Academic Standards and Progress:
 Los Rios CCD Administrative Regulation 7241: Graduation Requirements
- C. LRCCD BFSA Communication focusing on curriculum issues Brian Noel said that J. Oliver (AS) President asked that this be on the radar for DCCC. Rene Medina states that Deborah has a workshop. Shannon Giley (SCC AO) says they have workshops to continue to be equity minded. This group meets with disciplines as they go through program review with equity in mind. Brian Noel states that a concern from a curricular perspective is that some items in memo fall out of the purview of curriculum committee, such as the request made from memo regarding an equity-minded curriculum. Danny Siegfried voiced that this is important work, though such things as C-ID constrains what we can do with the COR. Roxanne Morgan states that CORs have been looked at at ARC with an equity-minded approach. She offered examples of textbooks that need to be re-imagined from an equity perspective. Brian Noel suggested that this equity training in Curriculum could be discussed in FLEX. Of course, this puts more work on faculty on the curriculum committee. Andi Hicks suggested that we have a shared file for these materials to share and that we ask the District for release time to do even more equity work as it relates to curriculum. On a relevant aside, Brian Noel stated that we could have a shared drive for Curriculum chairs to share ideas. Brian Noel in a related aside states that it would be valuable to have a shared google drive for the DCCC to communicate and tap into resources, such as agendas and minutes. Andi Hicks said that is something she will work on before our next meeting.
- XIII. Future Agenda Items. Danny Siegfried asked a question about the rules in relation to departments revising their ADTs with New to College courses that are only at tech review. This was unanimously rejected as a practice. Courses must be cataloged before ADTs are revised with these courses in them. It also raised a concern about C-ID approval that requires 45 days. The faculty should speak to the AO, Articulation is not retroactive, and typical articulation takes approximately two years, if not longer.
