 How do we keep shared courses from straying too far from each other? Whose responsibility is it? Department chairs should review revised courses as part of signature request in Socrates. Differences in courses can affect GE approval and

articulation. Several committee members expressed interest in revisiting the Rule of 5 and possibly expanding it. We may want to see what happens with the statewide common course numbering process.

B. Collaboration Across the District (Siegfried)
It feels like requesting a new designator or thematic block for a new program
that has already been approved by the Program Placement Council is redundant.
Clarification: the designator/thematic block request process is not asking for reapproval. It is used to track requests and make sure affected departments are
aware of upcoming changes through collegial consultation.
