- VI. Curriculum Proposals:
  - A. Courses/Programs by College

(All Courses/Programs are organized by college and listed at the end of this agenda.)

### ARC

- Course deletions: CSERV 2030 and 2031, GERM 351 and 352, LIBR 320, and ECE 414.
   GEOL 390 is being deleted but its content has been split up into several different new courses.
- New Program: Automotive Powertrain Systems Remanufacturing (Certificate).
- Motion made (Roxanne), seconded (Kate), and passed unanimously to delete the above courses and approve the new program.

### CRC

- New KINES 304 course.
- Motion made (Lisa), seconded (Roxanne), and passed unanimously to delete the above courses and approve the new program.

## FLC

- Motion made, seconded, and passed unanimously to approve this course.
   FLC
- Course deletion: ADMJ 370.
- New CISD courses will be a part of the new AI and machine learning courses. Also the new AI and Machine Learning program. Just got PPC approval at the end of last semester.
- Motion made (Roxanne), seconded (Shannon), and passed unanimously to delete ADMJ
   370 and approve of the CISD courses and the new program.

## SCC

- Deletions: BUS 107, RE 370 and 380 content is in other courses so no longer needed.
- New to District: New laws passed for cosmetology have resulted in new COSM courses.
   Two MET courses had content that were previously embedded in other courses, but these need to be broken out to treat the subject properly.
- New Programs: Data Science (A.S. Degree) and Real Estate Salesperson (Certificate).
- Motion made (Renee), seconded (Roxanne), and passed unanimously to delete the courses above, approve the new courses and programs.
  - B. Status of Collaboration Requests SWHS 360 (ready) -- currently at DCCC status so chairs can move these. CISN 341 collaboration request issue in joining an already established request. FITNS 331 and 339 are both held up at CRC. Also ARC's CISS 316 is held up but close to being approved by all of the colleges.
  - C. Course Designator/Thematic Block Requests SCC: CISD new thematic block request (2<sup>nd</sup> reading) – unanimous vote to approve

# VII. Action Item(s)

A. Adoption of Findings Related to Public Meetings Pursuant to AB 361: "The state of emergency continues to directly impact the ability of members to meet safely in person." – unanimous vote to approve. After this, DCCC may need to meet in person per Brown Act requirements. More clarification on this is coming. Tammy Montgomery agreed to follow up with Jake Knapp.

- X. DAS Report
  - Further discussion about meeting online as opposed to in person.
- XI. SAG Report
  - No SAG report as there has been no meeting yet this year.
- XII. Discussion Items
  - A. Awarding degrees for Business Administration ADT 1.0 and 2.0
    - i. When there is a substantive change to an ADT. An older version will sunset while the newer version will become a 2.0 version.
    - ii. The Problem: the application process for students opens Oct 1st of the year previous. However, by Oct 1 last Fall district did not yet have their 2.0 ADT ready yet. Students could not then sign up for the 2.0 degree and the 1.0 degree was no longer really valid. There were about 1000 students signed up for a 1.0 Business ADT when in fact they should have been signed up for a 2.0. Some students even received the wrong financial aid amounts considering the differences in course work between the two degrees. Students were informed of their catalog rights and moved in batches to the new degrees.
    - iii. A similar problem is now occurring with Communications Studies. Tammy is asking Curriculum chairs to propose a potential solution for putting the date for future degrees further into the future via Socrates. A meeting will be called within the month to discuss this further.
    - iv. See attached report from Tammy Montgomery "Report to DCCC on 2.0 Dilemma 27Jan2023" and the CCC Memorandum on TMC Phase In/Out for more details. Both can be found in the Jan 27 2023 DCCC Documents folder.
  - B. Los Rios Experience with Common Course Numbering (Medina)
    - i. Four curriculum chairs got an email from Bob Quinn from the State Chancellor's Office about our experience with AB 1111. Looking for perhaps three individuals to go and present about our transition. Meeting will be on Feb. 23rd on Zoom. Desire for Phil Smith to join this group since he has some insight in the numbering system. Rondha Farley at CRC. Also, Dennis Holden who helped co-write Socrates.
  - C. Brown Act & spring meetings
    - i. Efforts are being made to reserve the boardroom at DO for Spring meetings.
  - D. Articulation Officer Resolution
    - i. Last meeting had a robust discussion to get stable funding for hiring AOs.
    - ii. Jamie Nye wants to keep the funding local still rather than a blanket search for Articulation Officers (AOs) in the district.

iii. A DCCC Resolution is being drafted to build the "whereas" clauses and formulate a "resolve" statement that there be 100% AO staffing at each college. Local Senates and Curriculum committees will need to support it before it gets finalized. Look for further updates from Bill Simpson. Please see "AO Resolution report to DCCC" in the Jan 27 2023 folder for more details.

- E. DCCC Handbook
  - i. Bill is still drafting the handbook and working with the DAS president. Issues still to iron out: what we vote on, how we vote on it, and what constitutes a quorum. The draft is now at 1st reading for the February meeting. Should have a finalized version by March.

  - i. Tammy thinks this is a present need. Renee recommended the AA/AS Ethnic Studies Council to potentially serve on this. 1st meeting will be next week. Roxanne will take this request to the council.
- G. AB 928 (CalGETC) workgroup
  - Tammy thinks we might not need to finalize this group and the AB 1111 workgroup yet because there is still some information coming out about resources and implementation.
- H. AB 1111 (Common Course Numbering) workgroup
