CISN 341 ready to catalog (8/1/24)--two other Computer Science courses are close to catalog status. Looking for CRC folks to help these along.

C. Course Designator/Thematic Block Requests

FLC: CMED designator removal (1st reading)-- going to 2nd Reading.

SCC: FCS designator removal request (2nd reading)--On hold since CRC has a course in that designator currently. It was previously thought to be empty.

SCC: TELA new designator request (2nd reading)--The faculty think that the previous designator does not accurately describe those courses. Passed unanimously (M: Gilley, S: Al Juboori)

IX. Updates from the District Jamie Nye requested discussions about misinformation about prereqs for Math and English classes that are no longer required. Also, Tammy Montgomery informs us that credit for AP (Advanced Placement), IB (International Baccalaureate), and CLEP (College Level Examination Program) is not consistent across the colleges. Based on their performance on these assessments, there is also district-wide discrepancy in terms of the kinds of classes the exams would satisfy in our system. Tammy

is asking for an *ad hoc* group that will call for representatives to help address this issue. Shannon Gilley is asking that AOs have a hand in this since they are already working on alignment.

- XI. SAG Report Phil has recently added new TOP codes and the ability to request Cal-GETC in Socrates. Also, Cora (the public-facing COR server) is now available.
- XII. Discussion Items
 - A. Open positions on the committee ARC, FLC, and SCC are all short one voting-faculty member.
 - B. Chair-Elect Bill Simpson is looking for a new DCCC chair that he can train starting in September.
 - C. AB 1111 (Common Course Numbering) There will be a meeting next week, August 31. Still awaiting more information.
 - D. AA/AS Ethnic Studies graduation requirement. More on this in the weeks to come. Bill will ask DAS if the Ethnic Studies Council is already working on this.
 - E. AB 928 (CalGETC) Tammy thinks that this group needs to start meeting in September because there are going to be some significant things coming soon. Tammy will take the lead: Bill, Shannon, Megan, Juana, and Michael Lawlor have agreed to help.
