- IV. Vote for Zoom meeting next month Members voted "yes" to meeting on Zoom on November 15.

- VI. Chair's report DESSC is still missing classified members from ARC and CRC. Also there are no current student members that we know of. Bernadette will work on these membership gaps.
- VII. Discussion items
  - a. TES workgroup update (Sonia & BJ) Transcript Evaluation System Workgroup.
    - About 3 years ago, discussion around creating a platform to analyze equivalencies. ARC took the lead on this on a transcript evaluation system. Decided that all colleges should be involved.
    - ii. Representatives from all colleges in the district are in this group, including articulation officers and classified professionals.
    - iii. TES allows for articulation info to be loaded into the system
    - iv. Some nuances need to be determined
    - v. Molly showed a document describing the workgroup's mission and goals
    - vi. TES is used nationwide to store equivalencies. Many students take more units than they actually need evaluation doesn't happen until they

- petition for a degree. When system is in place, students know how which courses they have taken will count towards their degree.
- vii. Timeline is still TBD group meets again next week
- viii. See ETES Overview for more details on this workgroup.
- COVID- 19 update (BJ) It's going well. A large number of students have gone through the verification and exemption processes. Proof of vaccine is being evaluated by BJ's team.

  - ii. Los Rios is expecting increased volume / activity in verification or exemption for spring 2022
  - iii. Question about on-ground vs. online classes for spring, and how to plan services to students for spring semester. BJ isn't sure what it will look like, but pretty certain we will have more on-ground in spring that we currently have. This is more of a local question VPs of Instruction can be asked.
  - iv. Word on the street: FLC and CRC will have a minimum of 50% classes will be online; SCC will have 25% classes on ground, 75% online.
  - v. Los Rios employees are now eligible for the COVID vaccination booster. Visit My Turn - California COVID-19 Vaccine Scheduling & Notifications to schedule an appointment!
- c. Equity Consultants Report (BJ) Ongoing work by consultants. BJ will submit a formal report to District Academic Senate soon.
  - i. BJ meets with consultants weekly reviewing data on completion for AA and Latinx students in English and Math, will recommend strategies.

  - ii. Request from SCC Academic Senate president (last semester) for DESSC to take a formal stand against District centralization. We are now circling back to ensure there are no major concerns at this point (which is how it was in fall 2021.

  - i. District, Olga Prizhbilov Refugee Career Pathways program. There was a listening session a couple of weeks ago for students affected by situation in Afghanistan - a big success. A lot of students needed practical help. Resettlement agencies were present at this session which was very helpful.
    - 1. To come: on ground listening sessions at SCC (Nov. 22) and ARC (date TBD).
    - 2. Allied Health programs are very popular with our students in this particular population.

  - iv. CRC, Ea Edwards Inreach activities are happening around student ed plans - big campaign. Guided Pathways have similar events as well. Mike Chappell - in Counseling, approaches to mental health and who to contact at the District.

    - 1. Inna Tikhonov: Counseling provided in-person 30 to 40%. Spring, planning to do 50% on ground. There is a 100% show rate for in-person appointments. Now doing 1-hour appointments!

      - a. <u>The Power of Place, Race, & Identity: A Writing Workshop</u> <u>Featuring Mama C</u>. Califa Lit Collective is a new group that encourages BIPOC students to write outside of the classroom.

hires next year as well. FDIP (Faculty Diversity Internship Program) is looking for mentors at FLC.
