 - a. VII. Discussion items

a. Equity and Student Success Data (Betty Glyer-Culver)

- i. Download PowerPoint presentation:DO-PRIE DESSCPresentation 2021-November-15.pptx
- ii. The group looked at data enrollment numbers are course success rates during 2019-2020, in particular enrollment numbers, success rates, and throughput rates for African American and Hispanic/Latino students.
- iii. Q&A
 - 1. Leila: were there any name changes recently that would affect data? PRIE is very careful to keep track of this information.
 - 2. What is throughput? Calculation based on enrollment plus success in first year for first-time college students how many students enrolled and completed the course in question.
 - Distinction between Black and African American students -CCCApply added a bunch of categories for race (around 2019) these were incorporated into PRIE work. So students who identify as "Black" are included in the African American category for the purposes of this data.
 - 4. What do we do to improve these numbers? This falls under Instruction.
 - 5. Is there data around DSPS students? Yes this data is available on the PRIE dashboard.
 - 6. Question on queer & trans communities PRIE is gathering data on these communities.
 - 7. What stuck out about this data? More students were enrolled as a result of AB705, however large numbers of these students aren't doing well. However, enrollment numbers do reflect our increased efforts around enrollment.
- b. Advanced Education / Dual Enrollment update (Jason Ralphs)
 - Dual enrollment = statewide term that covers students who are attending high school and college simultaneously - can receive credit for both.
 Advanced ed = limited to a couple of classes, students get approval from HS and parents. CCAP - College & Career Access Pathways - part of Advanced Ed

 - iv. Discussion around combining Dual Enrollment and Advanced Ed into one workgroup to reduce duplication of members, etc. - DESSC will revisit this idea in January
