Welcome & Announcements

The zoom meeting was called to order by the faculty co-chair at 3:02p.

Approval of Notes from January and the Agenda

The agenda for today's meeting was approved, and the notes from the November meeting were approved.

Discussion Items

- Foundations 2.0 Clarification it was noted that taking the Foundations 2.0 course does not guarantee that faculty will be able to teach 100% online. Per the contract with LRCFT, faculty can teach .600 online up to .800 once they are tenured with a few exceptions when mutually agreed upon by the dean and faculty. The Foundations 2.0 website has information regarding this training and the compensation available. Changes were suggested to make the information clearer pertaining to the maximum allowable FTE that can be taught online. It was noted that faculty can receive compensation for both the 15 hours of Foundations of Canvas training (which needs to be taken first) and Foundations 2.0 training, but the training cannot be used to load balance and the self-paced ACCA training does not qualify compensation.
- Ed Tech Procedural Updates It was noted that District Academic Senate (DAS) can provide their input into topics discussed at Ed Tech, but they only have rights to control the direction and decisions related to 10+ 1 items. Per Board Policy 3412, only District Equity and Student Success Committee and District Curriculum Coordinating Committee report directly to DAS. Ed Tech is a non-senate led committee, so the co-chairs are only required to let DAS know of decision the committee will make on recommendations to the Chancellor. It was stressed that this should be more than an update to DAS; their input should be requested as they

represent the faculty voice. Ed Tech reports directly to the Chancellor but would always want to obtain DAS/faculty input on items related to classroom technology. Any Policy changes must go to the Board for approval in addition to going to VPI, VPSS, Academic Senate, and Chancellor's cabinet. Regulation changes do not need to go to the Board for approval. It was suggested that committee members review Board Policy 3412.

- <u>Proctorio Feedback</u> It was noted that Ed Tech recommended, and DAS agreed with the phase-out of Proctorio. A few complaints were received from faculty regarding disabling of Proctorio. It was noted that the Al flagging & room scanning features have been disabled. It was also noted that no language related to online proctoring being a requirement for a program to be accredited has been found. Other options to replace Proctorio are being researched, but finding and implementing a replacement is not guaranteed.
- <u>Title 5 Revisit</u> it was noted the AVCI spoke with General Counsel about the need to update our regulations related to the Title 5 changes. The General Counsel's office will be research language used in other districts and may call upon the committee for input. 55206-55204-55005
