Chair's Report (35 minutes)

- Full time hire requests for start date Fall 2022 (20 min)
 - o FLC is the only college to request a new hire for Fall 2022
 - No other colleges are making requests at this time.
 - o Feedback from colleges on requesting more than 1 new hire
 - CRC, SCC, and ARC would like to slow down the process. The work that is being done is completely uncompensated and therefore, it is important to acknowledge the amount of free labor that is being used in this process.
 - Even though this process seems rushed, it is the normal procedure and timeline for departments to request positions in the current fall semester for new hires the following fall. New hires should also be requested in the department program plans.
 - Discuss number of new hires to request based on student need (Tami)
 *see data attached at the end of the agenda
 - In order to meet the potential need for students, many more Full-time hires are needed. Please see data at the end of these minutes.
 - It is important to ask for new hires, and put these requests in program and department plans. ARC and SCC have the most need based on the number of students they graduate each year.
 - The Chancellor's office will issue a memo which will initiate the changes to graduation requirements. The colleges will then begin the work to change the graduation requirement through change in board policies.
 - These changes will not be immediate but will take effect over the next few years.
 - The change to require Ethnic Studies was pushed as a lower division requirement from CSU and UC Systems. The Community College System was then required to absorb and abide by these new requirements.
- The revised resolution pertaining to cross listed courses has been approved and supported by the DAS.
- We will be sending our 2021 Spring Council report to college admin teams, please be
 prepared to discuss with your college administration what the Council has done and is
 doing this semester if you have not been in consultation

- Pushback can happen when people are not aware of what we are doing. It is our responsibility to share information about our actions.
- CCCESFC Needs a location for their December Online Summit could we host? (Tami)
 (5 min)
 - We would need to set up a zoom link (technology), provide access and possibly create a flyer to post to the CCCESFC website & to our district website as well as college websites
 - Work with CCCESFC to organize the schedule and host- be available and in attendance the day of the summit
 - Invite our College Presidents & Academic Senate Presidents to welcome guests
 - Victoire is investigating hosting with the FLC Equity Center
 - Discuss this with Julie Oliver to see what the district can provide
 - There was concern about workload. We are not being paid or receiving release time for the work we are doing.
- CCCESFC Muratsuchi request to the LAO (Legislative Analyst Office) to investigate the CSU Area F approval process (Tami) (5 min)
 - Tami shared a letter from Assembly Member Al Muratsuchi. He is concerned that many colleges submitted courses for Area F approval, but were denied. He is particularly concerned that none of the Asian American classes were approved. He is requesting clarification of the process based on rates of approval. He is also examining the data based on the four core.
 - Many times the CSU reviewers do not provide enough feedback regarding denials. The feed back was very generic and simply stated that the course did not meet 3 of the 5 core competencies. No other guidelines were provided. Ethnic Studies Faculty reviewed these courses, but the process was very rushed, and they may have been under pressure to review hundreds of requests. This may have caused them to only look for exact wording rather than fully examine the content of the outlines.
 - It seems that only courses with word for word language received approval.
 - There is no way to tell if the current process will be the same as the previous process. Juana will look into it and report back to the Council.

 - Many good ideas were listed, but two that stood out were compensation and release time.

- 7. Statewide Ethnic Studies Taskforce Responsibilities- Request for feedback (Tami) (5 min)
 - To determine an implementation date for the new Ethnic Studies course requirement
 - To determine if and how to establish a unified definition of Ethnic Studies and/or core competencies for the California Community Colleges
 - To help coordinate professional development and technical assistance for the CCC's to ensure Ethnic Studies is implemented with fidelity to the discipline
 - This may be where we can request release time or other compensation
 - o To coordinate with the CSU for intersegmental alignment
 - There will be another requirement to coordinate with the UC System.
 - An Area 7 will be added to the IGETC. No additional units will be added.
- 8. It is important to look at the Ethnic/Multicultural category in curriculum. The current guidelines require a comparison of cultures, which Ethnic Studies does not do. Ethnic Studies focuses on centralizing the voices of the 4 core groups.
 - Current Ethnic/Multicultural Option: significant and substantial portions of the course deal with multicultural matters. The course examines significant aspects of the culture, contributions, and social experiences of underrepresented ethnic or racial groups in the U.S. or in the history and multicultural traditions of non-Western societies. The course compares two or more social groups, one of which may be European Americans. The course includes an analysis of the concepts of ethnicity, ethnocentrism, and racism, and how these concepts shape and explain ethnic experience.
 - Some faculty at the local level are concerned about whether or not their courses will meet this designation after it is changed. This will impact courses and departments who no longer meet the requirement.

Number of courses projected to be teaching each semester based on projected students graduating or transferring to a CSU -

- 1 ft faculty = 5 sections after the first semester or year
- 1 section = 40 students
- Projected rate of students = 200 per semester for 1 ft faculty
- 400 students per year for 1 ft faculty

How many students are graduating or transferring each year from each college?

Projections follow based on degrees awarded and transfer data from last year -

- ARC 2020-2021 AA/AS Degrees Awarded 1850, Transfers 807 *CSU not specified (CCCCO Data Mart website) projected estimated need = 5 ft faculty each teaching 10 sections over the year with 2-3 adjuncts teaching a couple of sections each semester
- FLC 2020-2021 AA/AS Degrees Awarded 803, Transfers 556 *CSU not specified (CCCCO Data Mart website) projected estimated need = 2 ft faculty each teaching 10 sections over the year with 2-3 adjuncts teaching a couple of sections each semester
 - FLC 2018-2019 CSU Transfers 379 (FLC Factbook 2019) est. 200-300 CSU transfer
- CRC 2020-2021 AA/AS Degrees Awarded 738, Transfers 567 *CSU not specified (CCCCO Data Mart website) projected estimated need = 2 ft faculty each teaching 10 sections over the year with 2-3 adjuncts teaching a couple of sections each semester
- SCC 2020-2021 AA/AS Degrees Awarded 1584, Transfers 720 *CSU not specified (CCCCO Data Mart website) projected estimated need = 4 ft faculty each teaching 10 sections over the year with 3-4 adjuncts teaching a couple of sections each semester

Please note that this is a snapshot of student need taking into account the number of students graduating or transferring within a year's time (2020-2021) assuming none have taken an Area F approved Ethnic Studies course over the time they have been enrolled at any given college in the district.
