- Continued discussion on how the Council will carry on and in what capacity
 - o We have invited Julie Oliver and Alisa Shubb to discuss ideas with the Council
 - Julie Oliver Back in Dec. 2020 The District Academic Senate approved the District Ethnic Studies Faculty Council as a subcommittee.
 - The goals of the committee must be updated: https://employees.losrios.edu/our-organization/committees/district-academic-senate/ethnic-studies-faculty-council
 - The goal of being in charge of equivalency needs to be pulled.
 - The opening statement about setting up departments and hiring should be edited a little.
 - You will need to continue with the Brown Act and continue as a sub-committee
 - Alisa Shubb Expressed agreement with Julie Oliver's comments.
 - It elevates the profile of Ethnic Studies
 - Walter Kawamoto The official subcommittee status will be useful as for future battles ahead.
 - Tami Cheshire Many core groups are being consolidated into Ethnic Studies
 Departments. Cross listing is also still a huge issue. This will put certain courses in
 jeopardy. We would have more power within our district.
 - Julie Oliver The membership may need to be tweaked a little bit. Membership should be reappointed every fall.
 - o Keith Heningburg In favor of continuing as a subcommittee.
 - Surangi Frazier We should keep up with the Brown Act whether we are a subcommittee or not. It is very useful for record keeping and tracking our progress.
 - o If we decide to continue as a subcommittee, we need to bring this to the DAS as soon as possible with a list of our new goals/adjusted charge
 - It is possible to vote a without all members present.
 - It is also possible to create an emergency meeting to make a vote.
 - o Goal ideas might include much of what we have been working on now

 towards Chicano Studies Major. ETHN 340 Introduction to Chicano
 Studies does count at Sac State for the Chicano Studies Major. All other
 courses do NOT count towards the major at Sac State. Other courses
 will only count for units to transfer. This may change with the
 development of the state level TMC.
 - It is important to be in discussions with Sac State and UC Davis to create
 a smoother process for students at Los Rios and other community
 colleges with regard to these discrepancies.

- Curriculum Update
 - There are 4 CSU Area F reviewers evaluating 500+ course submissions
 - We may not know about our Area F approval until probably May.
 - This will be problematic if any of our courses are rejected. There is a possibility to ask for emergency curriculum committee meetings before the June deadline. Tami Cheshire recommends making a contingency plan to have a meeting in May before classes get out.
 - It would be good to send to out a form letter from the council and per campus.
 - o Further discussion about changing designators ETHNS-AFAM, etc.
- Program Development Work group Fridays is anyone attending?
 - Google drive collaborative doc
 - Work on our AA's and Teaching Certificate
 - Ethnic Studies AA for students transferring to the CSU's
 - 4 Core Specific AA's for students transferring to the UC's

- TMC won't be ready until Feb. 2023, so we need to be careful how we develop our courses, programs and degrees to make sure they transfer/articulate as lower division courses within the Ethnic Studies major
- Dual Enrollment continued discussion about college specific programs vs. Council work, confirm it is college specific work but if we are creating professional development for teachers then that is Council work
- DESSC Dual Enrollment Charter currently has faculty vacancies. Victoire is currently on this committee. It would be useful to promote professional development for high school teachers and reduce cognitive dissonance between what is being taught in K-12 and college.
- Canvas repository for Ethnic Studies Resources and announcements was created thank you Surangi!
 - There is a place in the modules to share your syllabus. Please do so.
- The District Website can't be set to roll or make announcements. It is uniform. Any announcements would be listed in the agendas and minutes.
- Has everyone gotten to look at the Fall 2021 report yet? Any recommendations for changes?
 - Please look at so that Tami can send it to the District Academic Senate as soon as possible. It will also go out to the College Presidents and the Academic Senate Presidents. We will vote on it at the next meeting.

Dual enrollment is a possibility, but we need create agreements and getting in touch with counselors.

 - FLC (Tami Cheshire) Asked Eric Wada Academic Senate President to support state resolutions. Preparing request for another Ethnic Studies Faculty for fall. Is happy to work on requests with anyone else. Malika Hollinside will share her request as well.
 - o SCC (Keith Heningburg) Nothing new to report at the moment.
 - Debra Crumpton spearheaded a protest at the District Office regarding the threats against ARC President Melanie Dixon. The Managers and Black faculty got on board with it. The union was also supportive. The woman who made the threats is being held at the county jail.

ASCCC Resolutions To Watch

9.01 S22 Definition and Guidance for Cross-Listing Courses

Whereas, The Course Outline of Record (COR) is at the center of local curricular process; its required elements have been outlined in California Code of Regulations Title 5 § 55002 and the application of those requirements is detailed in the Program and Course Approval Handbook (PCAH);

Whereas the submission criteria for CSU GE Area F allows "courses without ethnic studies prefixes" to be submitted for Area F "if cross-listed with a course with an ethnic studies prefix", but the processes should maintain the integrity of the discipline and instruction; and

Whereas, there is a lack of system guidance on the definition and appropriate practice of cross-listing sufficient to guide colleges on course development and submission;

Resolved, That the Academic Senate for California Community Colleges works with the California Community Colleges Chancellor's Office to revise the Program and Course Approval Handbook to include a definition of cross-listing and guidance for its implementation; and

Resolved, That the Academic Senate for California Community Colleges work with the California Community Colleges Chancellor's Office to include in future publications, webinars, and other resources guidance and multiple examples of whether, how, and when to appropriately cross-list courses.
