## **Discussion Items (Concerns)**

- Review of suggested updates to R-7151 (instruction) and R-2214 (student services)
  - Adjustments need to be made to both regulations for them to match.
     The suggested changes will affect R-2214, 1.1.1.2, R-7151, 5.3.1.1, 8.3.1
     and 8.3.2 and need to be mutually agreed upon by all the colleges.

     Suggested changes are written in red on the handouts.
  - The TOFEL test is not the only test people use. There are many tests to choose from. Tammy suggested bringing the players together to agree on which test(s) we will accept and what or if we should name it so the requirements are the same for each college.

- Bernadette, Mayra and Yesinia will look at that and send some possible language to move toward agreement. Everyone is welcome to send their thoughts regarding possible language.
- G.P.A requirements are written in the regulations. Is there a reason why
  and is there anything in the Ed Code? G.P.A's are different in other
  countries and hard to understand. There are no processes to evaluate
  G.P.A.'s from other countries and most people find it too complicated to
  check.
- If a student can't show an equivalent of a high school diploma, then maybe we should apply the ability to benefit test?

#### Action Items

- See if there is anything in the Ed Code that comments on the requirements of International Ed.
- See what other community colleges' requirements are. Mayra will help look into this.
- A new issue was brought up regarding R-2214, 1.1.1.1 that states the equivalent of a U.S. high school diploma with a G.P.A. of 2.0 or above, or equivalent is required. The request is to remove the GPA requirement.
  - To change this will require a policy change that would need to go to the academic senate for discussion. This can be a new topic that we can come back to. Tammy will follow up.

#### Separating the regs and meetings for Study Abroad and IE

- Does the committee want separate meetings for IE and Study Abroad?
   Where would International Global studies reside? Would there be a third subcommittee of the committee or a separate committee? It was decided to try separating them.
- Tammy would like to see more of the people who work in International Studies at the table and also have some folks from global studies as well.
   Tammy will put a call out next fall for global studies people to attend one or both of the meetings.
