<b>Sequence of Basic Job Steps</b>	<b>Potential Hazards</b>	<b>Recommended Action or Procedure</b>
General Work Area	Injury due to slips, trips, falls due to uneven floor surfaces, curling rug corners, missing tiles Excess of paper/carbon dust, unsafe conditions, debris, blocked aisles	Repair/Replace floor surfaces to maintain an even surface. Clean and replace grates in ventilation ducts on a regular schedule. Report any unsafe conditions. Report all accidents, injuries and illnesses. Do not store excess amounts of combustibles in work area. Keep aisles clear. Know location of fire extinguisher and alarm devices. Practice evacuation procedures.
Storing/Retrieving materials and supplies	Bodily injury, falls, sprains	Provide adequate storage facility that allows easy access to and safe storage of heavy cartons of paper. Follow proper body mechanics lifting and moving heavy cartons.
Access	Slipping on stairs	Replace stairways with ramps which allow easy access when moving equipment and materials.
Chemically, emotionally and psychologically imbalanced students	Physical harm	Contact college police for assistance and protection if student appears to be out of control. Use non-aggressive communication skills.
Swing/Graveyard shift	Physical harm	Keep doors/gates locked which access grounds and building. Have a minimum of two operators for the graveyard and swing shift or provide college police for the area in addition to operator on duty.
Moving, installing PC's	Back injury, muscle sprain, dropping equipment on feet	Use handcarts to move equipment from one location to the other. Use proper body mechanics when lifting heavy or oversized cartons to avoid injury. Seek assistance of second person when attempting to move bulky or heavy items.
Video Display Terminal (VDT) / Computer monitor	Visual stress to improper lighting and work station design	Background lighting and screen lighting should be compatible and adjustable. "No Glare" screens should be provided. Eye care and rest periods should be provided as necessary. Screen position should be adjustable. Chairs and height of keyboard should be adjustable.
	Muscular skeletal injuries due to poor work station design	Employees should be trained to avoid muscular skeletal problems.
